### **COVID-19 Case Counts**

The Health Department of Northwest Michigan is reporting the following case information:

- On Tuesday, Jan. 4, 146 new cases of COVID-19 were reported in Antrim (21), Charlevoix (45), Emmet (49), and Otsego (31).
- On Wednesday, Jan. 5, 205 new cases of COVID-19 were reported in Antrim (47), Charlevoix (74), Emmet (61), and Otsego (23), and one new COVID-19 associated death in Emmet County.
- On Thursday, Jan. 6, 195 new cases of COVID-19 were reported in Antrim (40), Charlevoix (74), Emmet (63), and Otsego (18), and three new COVID-19 associated deaths in Antrim County (1), Emmet County (1), and Otsego County (1).

As of 4 p.m. January 3, the cumulative case count information for the Health Department of Northwest Michigan is:

- Total COVID-19 confirmed and probable cases in the following counties: Antrim (3,338), Charlevoix (3,720), Emmet (4,818), and Otsego (4,426).
- Recovered COVID-19 cases in the following counties: Antrim (2,920), Charlevoix (3,072), Emmet (4,050), and Otsego (3,862).
- Confirmed COVID-19 associated deaths in the following counties: Antrim (50), Charlevoix (53), Emmet (63), and Otsego (83).

On January 5, the State of Michigan reported 1,595,919 cases and 27,563 deaths.
